RESOLUTION TO ESTABLISH THE COMMUNITY DEVELOPMENT ADVISORY BOARD

WHEREAS, pursuant to §30-11-101(1)(e), § 30-11-107(1)(e), and §30-107(2)(e) C.R.S., the Board of County Commissioners of El Paso County, Colorado (BoCC) has the legislative authority to manage the concerns of El Paso County when deemed by the BoCC to be in the best interest of the County and its inhabitants; and

WHEREAS, in 1974, the U.S. Congress enacted the Housing and Community Development Act of 1974 (the "Act"), permitting and providing for the participation of the federal government in a wide range of local housing and community development activities and program which activities and programs are administrated by the U.S. Department of Housing and Urban Development ("HUD"); and

WHEREAS, the primary objective of Title I of the Act is the development of viable urban communities, by providing decent housing and a suitable living environments and expanding economic opportunities, mainly for persons of low- to moderate-income, this objective to be accomplished by providing financial assistance in the form of block grant funds to state and local governments for the conduct and administration of housing and community development activities and programs as contemplated under the Act; and

WHEREAS, pursuant to HUD's Notice CPD-08-04 (the "Notice"), El Paso County, Colorado (the "County") is qualified to participate in the Community Development Block Grant ("CDBG") program as an Urban County for Federal Fiscal Years 2009-2011; and

WHEREAS, the Intergovernmental Agreement between El Paso County and the City of Fountain and the Towns of Calhan, Green Mountain Falls, Palmer Lake and Ramah (Resolution No. 08-278) requires the County will establish a Community Development Advisory Board to make recommendations to the BoCC on the allocation of CDBG funds among the purposed CDBG programs and projects.

NOW, THEREFORE, BE IT RESOLVED THAT:

The Board of County Commissioners El Paso County, Colorado hereby approves the implementation and accepts the bylaws, attached hereto as Exhibit A, of the Community Development Advisory Board.
